II. SCHEMES FOR ONLINE PROGRAMMES

**The detailed fee structure for examination, other than the Examination Fee (per course) mentioned above, shall be notified separately at the time of examination registration.*

(a) Students belonging to the **SC/ST/OEC** categories shall be exempted from remitting the Tuition Fee, Examination Fee (per course), Admission Fee, and SLM Fee for each semester, subject to the following conditions:

1. They are not employed in Government, Quasi-Government, or Public Sector services;
2. They are not seeking admission to an additional Undergraduate/Postgraduate Degree Programme;
3. They have not previously availed of fee concession at the Postgraduate level, either through the University or through the concerned Block Panchayat.

However, such students shall remit all other applicable special fees, including the Registration Fee, Caution Deposit, and other similar charges.

(b) Students eligible for fee concession shall, in addition to submitting the online application, mandatorily apply for the concession through the Government of Kerala's e-Grantz portal. Failure to apply through the e-Grantz portal shall result in the denial of the concession, and the student shall be liable to remit the full prescribed fee.

(c) Students belonging to the OBC category, foreign nationals, and applicants seeking admission to an additional Undergraduate/Postgraduate Degree Programme shall not be eligible for fee concession.

(d) Blind students shall be eligible for admission only under **Scheme A**. Blind students admitted under Scheme A shall be exempted from remitting the Tuition Fee, Examination Fee (per course), Admission Fee, and Self-Learning Material (SLM) Fee for each semester, and they shall remit the Registration Fee and Caution Deposit, in accordance with the University Rules and the Government orders/directions issued in this regard, as amended from time to time.

Mode of Remittance: Fee shall be remitted online through the Instant Web Payment System provided in the admission portal.
